Brian G and Brad – Led Facility Updates discussion

 - Eight keys were made and seven have been passed out.
 - There will be a Key Policy that will need to be read and signed when keys are taken.
 - Brent provided a Wi-Fi update:
 - He is looking into the church Wi-Fi needs.
 - He will get back with Council on quotes through email.
 - He's proposing a Tech Committee: Brent, Carl, and Jeff.
